3. TERM OF AGREEMENT

- 3.1 This Agreement shall enforce for a period of 1 Years from the date hereof and thereafter renewable from the provisions as to termination upon mutual consent of the parties.

- 4.3 The Commission is a subject to be determined and declared by NELSIS LIMITED that According Table: 01 the approximate ratio (excluding VAT & Tax) for per Subscriber of Quick Ratio ERP Software and According Table: 01 for distributing others direct selling software and services of NELSIS LIMITED and DEALERSHIP SALES AGENT will receive their payment regularly at the end of 4th Month.
- 4.4 THE DEALERSHIP SALES AGENT is committed to provide Security Deposit (Full Refundable in Condition) to NELSIS LIMITED According Table: 01

9. EXCLUSIVITY

- 9.1 Both the parties agree with that the PARTNERSHIP agreement shall be exclusive in nature. The NELSIS LIMITED reserves the right to appoint other Company or Personnel for selling and distributing NELSIS LIMITED products/goods within the Territory or to sell directly to any customer within the DEALERSHIP SALES AGENT Territory during the Contract Period.

10. CONFIDENTIALITY

- 10.1 The DEALERSHIP SALES AGENT undertakes that it will not at any time divulge the information in relation to the NELSIS LIMITED affairs or business or method of carrying on business.
- 10.2 The DEALERSHIP SALES AGENT agrees that it will maintain as secret, and will not disclose to any Third Persons or Competitors. Secrets or other confidential information of NELSIS LIMITED obtained by the DEALERSHIP SALES AGENT in connection with the performance of this Agreement.
- 10.3 The DEALERSHIP SALES AGENT's obligation under this Clause shall remain in effect for a period of 2 (Two) years after the expiration or termination of this Agreement.

11. RELATIONSHIP OF THE PARTIES

- 11.1 Nothing in this agreement shall constitute or be deemed to constitute a PARTNERSHIP between the parties hereto constitute or be deemed to constitute the DEALERSHIP SALES AGENT as the agent of NELSIS LIMITED for any purpose whatever and the DEALERSHIP SALES AGENT shall have no authority or power to bind NELSIS LIMITED or to contract in the name and create a liability against NELSIS LIMITED in any way or for any purpose.
- 11.2 NELSIS LIMITED shall not be responsible for the illegal acts or bad nature faults of the DEALERSHIP SALES AGENT, Dealership Sales Agent or of its employees or representatives.
- 11.3 NELSIS LIMITED can take legal aid and action against the DEALERSHIP SALES AGENT or of its employees or representatives if such violation of rules and policy happens.

12. AMENDMENT & ASSIGNMENT

13.1 Upon the termination of this Agreement from any cause or at any time previous to such termination at the request of DEALERSHIP SALES AGENT, the NELSIS LIMITED shall promptly return to DEALERSHIP SALES AGENT or otherwise dispose of as DEALERSHIP SALES AGENT may instruct all material documents and papers whatsoever sent to the DEALERSHIP SALES AGENT.
